Agrawal College Campus, Viranjali Marg, Gandevi Road, Navsari-396445. On careful consideration of the proposal, the Government of Gujarat has decided to issue "**No Objection Certificate**" to applicant for the establishment of Ayurveda College with 100 (One Hundred) seats capacity for starting B.A.M.S Course for the academic year 2022-23.

It is certified that:

1. The applicant owns and manages a 100-beds hospital, which was established in the Year -2019.
2. It is desirable to establish Ayurveda College in the Public interest with admission capacity of 100 seats for B.A.M.S. Course.
3. Establishment of Ayurveda College with admission capacity of 100 (One Hundred) seats for B.A.M.S. Course at S.S.Agrawal Institute of Ayurveda, Agrawal Education Foundation, S.S. Agrawal College Campus, Viranjali Marg, Gandevi Road, Navsari-396445 is feasible.

This No Objection Certificate is issued subject to following conditions:-

- (1) College must appoint requirement regular staff & equipments before the inspection of as per the norms of C.C.I.M. An Undertaking with this regards

must be obtain from The Principal/Secretary, S.S.Agrawal Institute of Ayurveda, Agrawal Education Foundation, S.S. Agrawal College Campus, Viranjali Marg, Gandevi Road, Navsari-396445.

- (2) The college has to run the course on Self Finance basis and college will not ask for Grant in Aid in future. An Undertaking for this condition must be obtained by Director, AYUSH, Gandhingar, from The Principal/Secretary, S.S.Agrawal Institute of Ayurveda, Agrawal Education Foundation, S.S. Agrawal College Campus, Viranjali Marg, Gandevi Road, Navsari-396445.
- (3) The college must follow admission Rules and Regulation as well as fee structure as decided by the Government of Gujarat from time to time.
- (4) The College has to follow the Rules and Regulations prescribed by the affiliating University and Central Council of Indian Medicine, New Delhi from time to time.
- (5) The College must fulfill the norms of minimum standards prescribed by C.C.I.M New Delhi from time to time.

It is also certified that adequate clinical material as per norms of the Central Council of Ayurveda is available with the proposed/existing Medical College. It is further certified that in case the applicant fails to create infrastructure for the Ayurveda College as per Central Council of Ayurveda norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the student already admitted in the College with the permission of the Central Government.
